**Promotional Period for Introductory APR - Direct Visa, Platinum Visa, Signature Visa:**

The Introductory APR for purchases and balance transfers will apply to transactions posted to your account during the first 12 months following issuance of your card. Any existing balances on loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

**Loss of Introductory APR:**

We may end your Introductory APR for purchases and balance transfers and apply the prevailing non-introductory APR if you are 60 days late in making a payment.

**Other Fees & Disclosures:**

Late Payment Fee:

\$25.00 or the amount of the required minimum payment, whichever is less, if you are five or more days late in making a payment.

Annual Fee - Direct Visa, Secured Visa:

\$25.00.

Balance Transfer Fee (Finance Charge) – Direct Visa, Platinum Visa, Signature Visa:

\$10.00 or 2.50% of the amount of each balance transfer, whichever is greater. However, this fee is waived on all balance transfers posted during the promotional period stated above.

Balance Transfer Fee (Finance Charge) - Secured Visa:

\$10.00 or 2.50% of the amount of each balance transfer, whichever is greater.

Cash Advance Fee (Finance Charge):

\$10.00 or 2.50% of the amount of each cash advance, whichever is greater.

Returned Payment Fee:

\$25.00 or the amount of the required minimum payment, whichever is less.

Returned Convenience Check Fee - Direct Visa, Platinum Visa, Signature Visa:

\$25.00 or the amount of the returned convenience check, whichever is less.

Card Replacement Fee:

\$10.00.

Pay-by-Phone Fee:

\$5.00.

PIN Replacement Fee:

None.

Rush Fee:

\$35.00 overnight.

Statement Copy Fee:
