WHAT YOU NEED TO KNOW ABOUT OVERDRAFTS & OVERDRAFT FEES

An **OVERDRAFT** occurs when you do not have enough money in your account to cover a transaction, but we pay it anyway. We can cover your overdrafts in two different ways:

- 1. We have standard overdraft practices that come with your account.
- 2. We also offer **overdraft protection plans**, such as a link to another account or a line of credit, which may be less costly than our standard overdraft practices. To learn more, ask us about these plans.

THIS NOTICE EXPLAINS OUR STANDARD OVERDRAFT PRACTICES.

» What are the standard overdraft practices that come with my account?

We <u>do</u> authorize and pay overdrafts for the following types of transactions:

- Checks and other transactions made using your checking account number (ACH auto debits)
- · Automatic bill payments and recurring debit card transactions
- · TellerPhone and eBanking transactions

We will not authorize and pay overdrafts for the following types of transactions without your consent.

- ATM transactions
- Everyday debit card transactions

If we do not authorize and pay an overdraft, your transaction will be declined.

We pay overdrafts at our discretion, which means we <u>do not guarantee</u> that we will always authorize and pay any type of transaction.

» What fees will I be charged if Signal Financial Federal Credit Union pays my overdraft?

Under our standard overdraft practices:

- We will charge you a fee of \$31 each time we pay an overdraft
- There is no limit per day on the total fees we can charge you for overdrawing your account

» What if I want Signal Financial Federal Credit Union to authorize and pay overdrafts on my ATM and everyday debit card transactions?
